General overview of her experience:

- ✓ participation in the monitoring Poland regulatory updates on the international level,
- ✓ participation in the preparation of workplaces for audits as well as participation in the audits themselves in the following industries: power generation, metallurgy, construction, steel and plastics industry, as well as sector;
- ✓ responsibility for managing all HSE-related processes;
- ✓ vetting and documenting the compliance of all project-relevant specifications;
- ✓ development of guidelines for safety plans, as well as organising and conducting staff training;
- ✓ development and implementation of solutions to maintain and extend OHS policy;
- ✓ development of the project-specific HSE Plan and the HSE standards and instructions;
- ✓ risk assessments: verification of the availability and feasibility of the work method statement (including risk analysis); support for the development of risk assessments;
- ✓ recommendations and adaptation of the fire protection concept;
- ✓ preparation of corrective measures and follow-up activities;
- ✓ verification of the compliance of the Safety Certificate Contractors (SCC) system (safety, health and environmental management for subcontractors);
- ✓ development of incident reports, including analysis and implementation of appropriate measures;
- ✓ analyses and measures necessary in the case of high-risk incidents;
- ✓ on-line support for companies during the update of the necessary documentation in the field of health and safety and environmental protection, including monitoring of Polish law;
- ✓ set-up of the HSE department from scratch, while following the guidelines, including performance of the following tasks:
 - implementation of system solutions based on company strategy;
 - participation in the implementation of rights and obligations and the scope of competences resulting from the Labour Code and the Regulation of the Council of Ministers;
 - participation in shaping business culture and improvement of interpersonal skills required in an international work environment;
 - co-ordination of the implementation of the Integrated Management System, including recently ISO 9001: 2015, ISO 14001: 2015, ISO 45001: 2018;
 - work in the capacity of an internal auditor of the Integrated Management System;
 - participation in the supplier selection process (analysis, negotiations, etc.);
